Changes to Reg CC

Beginning July 1, 2020, please be aware of the following changes to GT(BC)EFCU's Funds Availability Policy.

Next-Day Availability: Increase from \$200 to \$225 in the amount of certain check deposits (non-next day items) that must be made available on the next business day following the banking day of deposit.

Exception Hold for New Accounts: Increase from \$5,000 to \$5,525 in the aggregate amount of next-day items deposited in person to a new account that must be made available on the next business day following the banking day of deposit (or the second business day, if the deposit is not made in-person).

Exception Hold for Large Deposits: Increase from \$5,000 to \$5,525 in the amount of aggregate deposit made on a single day that are subject to this exception hold.
